



# UPES focus on Research 100 kW Solar Power Plant at UPES campus

R&D activities at UPES emphasize the quest for scientific and technological innovations to become industry oriented and developing into an internationally recognized R&D organization. UPES can then play a pivotal role in the development of hydrocarbon and related industries. The proposed investment on new equipments, infrastructural facilities and the plans for enhancement of collaborations with national and international industrial and R&D organizations will boost UPES' efforts in attaining the objectives that it has set for itself.

urrently, UPES is equipped with specialized state -of-the-art laboratories, an integrated Bio- diesel pilot plant, Jatropha de-oiled cake based biogas plant, engine and vehicle testing facilities with ethanol, bio-diesel blended fuels, technical performance analysis of dieselethanol blends in IDI diesel engines, etc. Additionally, present day analytical facilities and standard test methods for testing of crude oil and its products are part of the R&D facilities. A 100 Kw<sub>p</sub> Solar Photovoltaic Plant has also been made operational. Tools for contemporary research such as state-of-the-art process design and simulation softwares, e.g., ASPEN, CFD, MATLAB, SCADA, SOLIDWORKS (3D&2D modeling) PETREL, ECLIPE, CIMG and host of in-house softwares for kinetic modeling, statistical analysis and general computation facilities have been made available.

To realize its vision, UPES is currently pursuing research in some selected areas either through collaborative or inhouse research projects. Some of the currently focused areas for research include alternative fuels, biodiesel from rural fuel sources including pilot plant studies, bio-fuels and biolubricants and their applications in IC engines. Research is being persued in evaluation of fuels and lubricants, biotechnology, catalysts for refinery processes, specialty chemicals & products, petrochemicals, energy efficient biological processes (e.g., bio-processing of crude, biotreatment of wastewater, bio-remediation of soil and ground water). The other areas of research are integrating state-ofthe-art technology (e.g., separation, catalysts, sensors & control, bio-technology, etc). Effective and well understood process models for process optimization is yet another area for studies.

UPES has also initiated **knowledge based work** in several areas which include business model for clean development mechanism, energy conservation through creating awareness (educating the public). The establishment of an ICT driven Village Knowledge Centre is also mandated for societal benefit and environmental awareness.

UPES is equipped with standard test techniques for **R&D** 

**Services** on performance evaluation of crude oil and its

products, fuels and lubes. These services can be provided to external organizations as well. UPES has also created enabling infrastructure to provide Services in **Engine & Vehicle Testing** for following purpose:

Feasibility of blending Straight Vegetable Oil (SVO) in petro-diesel and utilization on IDI Diesel Engine.

Endurance analysis and tribological studies of diesel engines fueled with bio-butanol, diesel and their blends as alternate fuel.

Performance evaluation of diesel engines using Ethanol – biodiesel blends.

Technical performance analysis of diesel-Ethanol blends in DI Diesel Engine.

Future R&D at UPES is directed to technology development relevant to industry. This includes reducing green house gases primarily utilizing Carbon dioxide as raw material, exploration and production of Coal Bed Methane (CBM), development of catalysts for isomerisation and dimerisation of lower alkanes etc. Performance evaluation and enhancement of existing Solar Photo Voltaic cells, development of Bio-semiconductor for Photo Voltaic cells, design, development and commissioning of a concentrated solar Thermal Power plant, performance evaluation and enhancement of solar thermal devices are some of the identified areas for future research. Power generation from biogas, hybrid power conditioner and converter for onsite power generation using biogas and fuel cell, establishment of jatropha de-oiled cake based biogas plant, production of bioethanol & biobutanol from lignocellulosic biomass, catalytic conversion of lignocellulosic biomass into fuel grade liquid hydrocarbons and biodiesel from micro algae based biomass are some of the other areas being investigated.

Gasification of coal and power generation from Chir Pine by gasification are the areas of interest at UPES. Hydrogen is being looked forward as the everlasting clean and renewable future fuel. UPES has also initiated studies on hydrogen production & utilization. Additionally, use of SVO with hydrogen supplementation in an IDI diesel engine is being investigated.

Multi fuel "NEELAM" Chulha <u>(Chir Pine </u>– Biogas – LPG)

Recognising that developments in Science and Technology should contribute to improve quality of life for the weaker section of the society, UPES has set up a Bio Gas Development & Training Centre with funding from MNRE. Additionally, NEELAM CHULHA capable of firing on LPG, Bio Gas and Biomass specifically Chir Pine Needles in the form of Briquettes, Chir Pine Cones and Lantarna (Weeds) has also been developed, and successfully demonstrated. Further initiatives to cater to the Energy needs in a village environment for a group of families towards self-sufficiency in Fuel and Power are in progress.

## MOU with National University of Juridical Science (NUJS), Kolkata

# Emerging calls of law and the new roles of lawyers

The empire of law is expanding as definitely as the demands and motions of democracy and open society. A contemporary historian of ideas and institutions may well begin with the upheavals of thoughts and social movements of the past two centuries, the great appeal of communist ideology and alongside, the opposite, freedom and liberty. She may narrate chronicles of supremacy of individual freedoms - catalogued in national and transnational instruments and write footnotes on the enormous unleash of human creativity, the new forms of human resources and the need for order and equality. The course of this narrative perhaps cannot escape noticing the challenges emerging from new frontiers of knowledge, and human endeavours to create new resources and products, and the political processes endeavouring to secure these closer to the needs of all humanity - obliterating inequalities and disparities.

All of earth's resources and the potential of the universe to the extent accessible to human reach are now open books of knowledge. The march of science and technology has made possible rapid additions of new chapters of knowledge and product making. Correspondingly globalization has impacted and will continue to impact several dimensions of our lives, by way of "generating transcontinental or interregional flows and networks of activity, interaction, and the exercise of power". Financial markets and their integration, intrusive technologies, economic and legal integrations, profound changes in the nature and forms of work, have pushed human relationships and the location and exercise of power into new dimensions and frontiers.

The object of this brief glimpse is not to undermine or negate the eternal importance of survey and critique

of human interactions, resources command – in private hands or State instrumentalities – and the ultimate ends of creating a just and equitable social order – domestically and worldwide. No flags are raised in honour of exclusivity of any economic or political system. Yet the un-diminishable value of all freedoms and their relevance to human well being and peace cannot be lost sight of. It is in this total context that the need to comprehend and take stock of exciting areas of law, and their manifold relevance deserves to be noticed.

An expanding genre of legal writing on issues and subjects of alphabetical stretch tell us about the silent and quiet revolution of human activity and ideas, worldwide. The new subjects of human activity produce corresponding subjects of rights, responsibilities, regulation, control and ultimately justice. Writing on the impact of internationalization of law, a recent study observes thus:

"Some legal fields, including the study of legal profession, have always been more internationalized than others. Areas of law most closely connected with international trade and multinational companies, such as international business contracts, anti trust law and competition policy, financial markets, intellectual property, the internet and new technology, cyber crime, national security, labour and social law, labour regulation and new forms of work, and now environmental law and public interest law, have been affected more than family law and property law. But even discounting for our lack of empirical knowledge of the effects of globalisation of many areas of law, it is clear that the internationalized sector has tended to grow, despite national and local diversity."<sup>2</sup>

Let me illustrate: The study of company law is no longer a matter of mere internal management. It transcends the borders of private law of obligations of shareholders and stretches into public law and obligations to and compliances with several societal demands. The study of taxation is not merely the study of accounting and computation in terms of tax liability provisions, but also a compendium of benefits, exemptions, concessions and thus a study of law,

economics international and Trans border trade and commerce and promotion of industry and innovations. The study of intellectual property is today a study of private appropriation of, inventiveness, novelty and originality among other matters in respect of chemicals, Pharmaceuticals, Bio-technology, designs, packing, advertisements, apparels and more that relate to several fields of human activity. Space law invites debates on regulation and responsibilities; Energy laws may entail questions about equitable distribution and the impact on existing notions of private and public obligations etc.<sup>3</sup> Thus the engineer of law is today called upon to understand the role and relevance of engineering; the scientist of law is called upon to deal with the integration

of science and its position in key areas of life.

Aboriginal Art is also a contender for intellectual property rights; Traditional medicine systems are healthy competitors in the health care arena; Alternate forms of energy and their technological innovations are slowly attaining greater visibilities; Environmental concerns are propelling sustainable technology movements. It may thus not be an exaggeration to state that niche segments of contemporary human activity call for exalted roles for law and lawyers – as policy makers, as explorers, as science and technology collaborators, as mediators and conciliators, and thus in advancement of humanity and justice.


